

PRIVACY POLICY

According to the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC, we would like to inform you that:

1. The controller of your personal data is PHU Jantar Ryszard Łach with headquarters in Gliwice (44-100) at ul.Chorzowska 50, phone: 32 401 09 51, e-mail address: biuro@gorskidworek.pl
2. The purpose of processing your personal data is:
 - a. handling inquiries and preparing an offer for renting apartments in the facilities of Residence Górski Dworek in Kościelisko;
 - b. booking of apartments in Residence Górski Dworek in Kościelisko;
 - c. performance of the contract for the rental of apartments in the facilities of Residence Górski Dworek in Kościelisko;
 - d. ensuring the safety of people and property located in the facilities of Residence Górski Dworek in Kościelisko through the use of visual monitoring;
 - e. ensuring the safety of people and property located in the facilities of Residence Górski Dworek in Kościelisko by identifying all people staying in a given apartment.
 - f. newsletter delivery.
3. You have the right to access the data and rectify, delete or limit its processing, as well as the right to object, request the cessation of data processing and transfer, as well the right to withdraw consent at any time and the right to lodge a complaint with the supervisory body, i.e. : President of the Personal Data Protection Office.
4. Providing data is voluntary, but necessary to prepare and send an apartment rental offer and make a reservation. If the data is not provided, it will not be possible to prepare and send the rental offer of apartments as well as making a reservation and providing apartment rental services in the facilities of Residence Górski Dworek in Kościelisko. By subscribing to the newsletter, you provide us with your e-mail address and your first name via the newsletter subscription form. Providing data is voluntary, but necessary to subscribe to newsletters. These data are used to send you a newsletter, and the legal basis for their processing is your consent.
5. The recipients of the data provided by you may be:
 - a. an external accounting office;
 - b. entities solely entitled to obtain personal data on the basis of the provisions of law;
6. Your data may be processed by third parties to whom I commission the performance of specific activities related to ensuring the proper functioning of the website. Entities to whom I order processing personal data, guarantee the application of appropriate measures for the protection and security of personal data required by law. Entities entrusted with data processing are:
 - a. dhosting.pl Sp. z o.o., Al. Jerozolimskie 98, 00-807 Warsaw, NIP: 701-019-83-61 - data processing for the functioning of the website on the server.
 - b. LEMONPIXEL.pl Roman Korczyński, ul. Młyńska 12A, 58-570 Jelenia Góra, NIP: 611-227-24-45 – processing personal data in order to make a reservation in the HOTRES system.
7. The data provided by you will not be profiled.
8. The data controller will not transfer your personal data to a third country or international organization.
9. Your personal data obtained in connection with the concluded contract for the provision of apartment rental services will be processed during the period of limitation of tax claims or civil law claims of PHU Jantar Ryszard Łach or a Guest, whichever occurs later. Data obtained only in connection with inquiries and the preparation of an apartment rental offer in the facilities of Residence Górski Dworek in Kościelisko will be processed for a period of 3 days from the date of fixation, and then will be permanently deleted. Data provided in connection with subscribing to the newsletter will be processed for the duration of its operation, unless you resign from earlier receiving it, which will delete your data from the database.
